

**Reportable Crimes for all Michigan School Employees  
MCL 380.1535a**

**1. Any felony**

**2. Any of the following misdemeanors:**

- a. Criminal sexual conduct in the fourth degree or an attempt to commit criminal sexual conduct in the fourth degree
- b. Child abuse in the third or fourth degree or an attempt to commit child abuse in the third or fourth degree
- c. A misdemeanor involving cruelty, torture, or indecent exposure involving a child
- d. MCL 33.7410 – Delivery or distribution of marijuana to minors or students near school property
- e. MCL 750.115 – Breaking and entering, or entering with out breaking, without permission
- f. MCL 750.141a – Consumption or possession of alcohol by minors or controlled substances at social gatherings
- g. MCL 750.145a – Accosting, enticing or soliciting child for immoral purposes
- h. MCL 750.359 – Removal or damage to any property belonging to, connected with, or used in construction of vacant building or structure
- i. MCL 750.81 – Assault and assault and battery including domestic assault
- j. MCL 750.81a – Assault and assault and battery including domestic assault
- k. MCL 750.145d – Internet crime against a minor
- l. MCL 750.335a - Indecent exposure
- m. MCL 436.1701 – Prohibited sale of liquor to minors

**If convicted of any of the following crimes your employment will be terminated as a Michigan School Employee**

- Accosting, enticing, or soliciting a child for immoral purposes.
- Involvement in child sexually abusive activity or material.
- A third or subsequent violation of any combination of engaging in obscene or indecent conduct in public, indecent exposure, or a local ordinance substantially corresponding to either offense.
- First, second, third, or fourth degree Criminal Sexual Conduct (CSC).
- Assault with intent to commit CSC.
- If the victim is less than 18 years of age, the crime of gross indecency (except for a juvenile disposition or adjudication), kidnapping, sodomy, or soliciting another for prostitution.
- Leading, enticing, or carrying away a child under 14 years of age.
- Pandering.
- Any other violation of a state law or local ordinance constituting a sexual offense against an individual less than 18 years of age.
- An offense committed by a sexually delinquent person.
- An attempt or conspiracy to commit one of the offenses listed above.
- Any offense under the laws of the United States, any other state, or any other country or tribal or military law, that is substantially similar to a listed offense.
